PRESIDENT'S REPORT

I am pleased to again provide this biannual review of Rome Foundation activities and there is a great deal to report. In this column I will provide some

of the major initiatives underway and also offer a quick link to services and activities through our website.

In May 2011 we began a new educational initiative to highlight the most important abstracts on Functional GI and Motility Disorders presented at DDW. Several members of the Rome Foundation Board selected, reviewed and prioritized the highest quality posters and oral presentations at the meeting. Using this information the Foundation produced a CME webcast: "The Rome Update from DDW". Drs. Douglas Drossman, William Whitehead, Lin Chang, Bill Chey and Jan Tack selected and critiqued the abstracts and Drs. Bill Chey, Lin Chang and Nick Talley reported them using a news media format. We plan to continue this educational program annually at DDW.

Our collaboration with the American Gastroenterological Association continues to provide important educational initiatives to AGA members and attendees. The **Fifth Annual Rome Foundation – AGA Institute Lectureship** which will be held at DDW 2012 will address a hot topic in the area of FGIDs: "Intestinal Permeability in Gastroenterology and its Relevance to Functional GI Disorders." We are privileged to have two internationally recognized speakers: Johan Söderholm MD, PhD from Linköping University will discuss "Stress, Gut microflora and their effect on Intestinal Barrier Function in Functional GI Disorders." Also Alessio Fassano, MD from the University of Maryland will discuss "Regulation of Intestinal Permeability in Health and Disease." The meeting will be held at the San Diego Convention Center on Sunday May 20 from 10:30 AM—12:00 PM.

We are also pleased to announce a new Rome Foundation AGA Institute Communication Skills Workshop which will be held in April 2012. This 1½ day workshop will focus on effective communication and management skills relating to patients with FGIDs. The goals are to increase patient and personal satisfaction, and provide more effective management techniques to achieve better outcomes. The specific objectives are: 1) To understand the pathophysiological, diagnostic and treatment aspects of patients with IBS and other FGIDs, 2) To understand how to conduct a patient-centered biopsychosocial interview that optimizes time and enhances the patient-doctor relationship, and 3) To learn how to manage "difficult" clinical situations (e.g., anger,

dependency, clinical uncertainty, emotional distress, reports of abuse, etc.). By using a series of lectures and demonstration, small group sessions and live facilitated interviews attendees will learn effective clinical techniques from experienced facilitators. 

Education

There are both continuing and new educational programs that the Rome Foundation has been working on. These include the Rome educational slide sets on FGIDs, the Meet the Experts session at the UEGW 20122, the annual Rome-AGA lectureship at Digestive Diseases Week (DDW) meeting, and a Best of DDW FGID abstract webcast.

Rome educational slide sets

The Computer-Based Learning Program includes state-of-the-art slides that brings to life information from the Rome III book on FGIDs. This educational program is endorsed by AGA Institute. The slide set includes a wide range of information that spans from epidemiology to pathophysiology to treatment. A number of animations, videos and conceptual slides help to communicate ideas that may otherwise seem difficult to convey. Notes and legends for every slide give a description of the slide with key references.

Best of DDW webcast

At last year's DDW, Rome Foundation Board members reviewed and selected the best abstracts on FGIDs. Working with the GI Health Foundation on this educational endeavor, Drs. Nick Talley, Bill Chey and Lin Chang presented these abstracts during a webcast. This webcast is now available on line at www. focusmeded.com/special event/rome2011/index.cfm.

Meet the Experts session at UEGW 2011

There will be a Rome Foundation Symposium entitled, "Management of Difficult Patients with Functional GI Diseases" which will be held on Monday, October 24, 2011 at 5:30-6:30pm

at Room K24 at the Stockholm Exhibition & Congress Center. Rome Board members Drs. Robin Spiller and Fernando Aspiroz will be moderating the session. There will be three lecturers who will speak on "How I manage a difficult case of..." Dr. Javier Santos will give a talk on Food Allergy, Dr. Magnus Simrén will lecture about IBS in IBD and Dr. André Smout will discuss Postfundoplication Dysphagia.

Fifth Annual Rome-AGA lectureship at the DDW

The upcoming lectureship at the 2012 DDW meeting will be entitled, "Intestinal Permeability in Gastroenterology and its Relevance to Functional GI Disorders." There will be two internationally recognized and respected scientists who will be giving complementary lectures. Dr. Alessio Fassano, Professor of Medicine, Pediatrics and Physiology at the University of Maryland, will be speaking on the "Regulation of Intestinal Permeability in Health and Disease." Dr. Johan Söderholm, Professor of Surgery at Linköping University in Sweden will speak on "Stress, Gut microflora and their effect on Intestinal Barrier Function in Functional GI Disorders." The objectives of this lectureship are to: 1) Review the current understanding of the regulation of intestinal permeability in health, 2) Discuss pathophysiologic mechanisms involving intestinal barrier function in functional gastrointestinal disorders, and 3) Understanding the ways in which altered intestinal barrier function translate into functional GI symptoms. Rome Board members, Drs. Doug Drossman and Lin Chang, will moderate the session. The lectureship will take place Sunday, May 20, 2012, 10:30am - Noon (specific location at the San Diego Convention Center TBD).

ROME TRANSLATION PROJECT - UPDATE

AMI D. SPERBER, MD, MSPH CHAIR, TRANSLATION PROJECT

The Rome Translation Project was established to oversee the translation of all relevant Rome Foundation material, in particular the *Rome III* book, the Rome III diagnostic questionnaire, and the Rome clinical algorithms. The diagnostic questionnaire and criteria, in its approved language versions, will be available for use in epidemiologic studies and clinical trials.

The webpage for the Rome Foundation Translation Project is now complete and contains the following links:

- 1. A table of 17 available language versions and translation projects in progress or about to start.
- 2. A request form for translated material.
- 3. Licensing and fees information.
- Rome Foundation guidelines for new language translations.

The project has developed official guidelines for translation of the materials that must be followed before Rome Foundation approval is granted. The project will both monitor translation initiated by others and initiate translations itself. Approval is required for all uses of translated versions of the Rome material including research and education.

Working Team on cross-cultural, multinational research

The Rome Foundation appointed a working team on Cross-cultural, Multinational Research, which is expected to prepare a summary document of its work within two years. This document and other material prepared by the committee will serve several chapter committees for the Rome IV book.

The committee roster is: Ami Sperber, chair and members Enrico Coriazzari, Shin Fukudo, Charles Gerson, Uday Ghoshal, Kok Ann Gwee, Pali Hungin, Max Schmulson, Brennan Spiegel, Lynn Walker, and Bill Whitehead.

The working team has been divided into three sub-committees:

- 1. Systematic global review of IBS/FGID epidemiology Mandate: To conduct a global systematic review of the epidemiology of IBS to be published as (1) part of the working team's report, (2) as part of the Epidemiology section for Rome IV, and (3) as a standalone publication in a leading GI journal. Dr. Dumitrascu has agreed to serve as a consultant to this sub-committee.
- 2. Methodology issues in cross-cultural, multinational research

Mandate:


- a. Study design
- b. Availability and development of appropriate study instruments
- c. Translation and validation of study instruments
- d. Subject recruitment including culturally-related inclusion and exclusion criteria
- e. Development of culturally appropriate endpoints and outcomes
- f. Other methodological issues

- 3. Fostering cross-cultural, multinational research Mandate:
 - a. Development of research networks
 - b. Potential research areas, e.g., epidemiology, pathophysiology, clinic treatment trials, etc.
 - c. Delineation of specific research projects that the committee believes should be prioritized.
 - d. Avenues for collaboration with other organizations, pharmaceutical companies and regulatory agencies

Eamonn Quigley has agreed to serve as a **WGO liaison** to this sub-committee to further collaboration between our two organizations as well as in the interest of gaining from his expertise and insights.

The anticipated working team products are:

- a. A paper/s on the epidemiology of IBS
- b. An inclusive document that will serve as support material for the Rome IV book
- Guidelines for the development of research networks and multinational collaboration and for the conduct of multinational, cross-cultural research in the FGIDs

2012 RESEARCH GRANT AWARDDeadline for applications – December 16, 2011

- Amount of award \$50,000
- Awarded to: Investigator-initiated research that promises to develop knowledge in the field of functional gastrointestinal disorders (FGIDs)
- Applications are given preference that:
 - Test the validity and/or utility of the Rome III diagnostic criteria,
 - 2. Assess the epidemiology of functional GI and motility disorders, or
 - 3. Advance knowledge of outcome assessment or trial design for FGID treatment trials

- All applications are submitted for an external NIHstyle review by an independent review committee.
- Award will be presented at the Rome Reception during Digestive Diseases Week 2012 (DDW)

2012 RAY CLOUSE AWARDS FOR RESEARCH PUBLICATION IN FUNCTIONAL GI AND MOTILITY DISORDERS Deadline for nominations – March 16, 2012

- Amount of prizes (2) \$500
- Best Original Research Paper published January to December 2011: Published papers on empirical research related to functional GI or motility disorders, defined broadly, not excluding any category. Reviews and clinical guideline papers are not eligible.
- Most Cited Paper published between January and December 2010
 Most frequently cited paper will be identified by Web of Science
 search engine.

The lag between publication (2010) and eligibility (2012) is two years to insure adequate time to judge the frequency of citations and to avoid disadvantaging papers published towards the end of the calendar year.

Papers authored by Rome Foundation board members are not eligible.

NEW WORKING TEAM - THE ROLE OF FOOD IN FGIDS

Patients have long associated their IBS symptoms with ingestion of certain foods, combination of foods, or a meal itself. In fact, more than 60% of IBS patients report worsening of symptoms after meals; 28% of these within 15 minutes after eating and 93% within 3 hours. Unfortunately the relative lack of empiric data proving a causal link or consistently documenting symptom improvement has caused health care providers to view dietary interventions with skepticism. Further, gastroenterologists and primary care providers receive virtually no structured training in dietary interventions for IBS. This lack of enthusiasm for dietary counseling has increasingly caused providers to be misaligned with their patients who commonly ask for more holistic solutions for their IBS symptoms.

It is now clear that a number of disorders and diseases can masquerade as or exacerbate the symptoms of IBS. For example, few clinicians would dispute that celiac disease and lactose intolerance are important considerations in patients presenting with IBS symptoms. However, these two well defined disorders likely represent the tip of the iceberg as it pertains to the role of food in IBS. For these reasons, the Rome Foundation has commissioned a multidisciplinary group to carefully evaluate the evidence which supports a role of food in the pathogenesis and management of FGIDs. The working group will be co-chaired by William D. Chey and Jan Tack. Other members of the group will include Fernando Azpiroz, Sheila Crowe, Shanti Eswaran, Peter Gibson, and Susan Shepherd.

The working group hopes to have a final document in press at a high quality peer reviewed journal by the time the Rome IV committees commence their work in May of 2013.

WORKING TEAM ON THE ROLE OF THE INTESTINAL MICROBIOTA IN EGIDS

MAGNUS SIMRÉN, MD, PHD CHAIR

One of the goals of the Microbiota working team was to produce an extensive background document including all the relevant references and information of relevance, as well as a clinically useful review submitted to one of the major scientific journals in our field. That document is now in its final stages of completion. The background manuscript will be submitted for internal review shortly, and the short manuscript will be submitted to Gut as "Recent Advances in Clinical Practice". In addition, two lectures based on the work of this group will be given at a symposium within the congress entitled "Today's Science; Tomorrow's Medicine: Role of Bacteria in Health and Disease" (Tuesday, October 25; Session: "Microbiota in colorectal cancer, liver disease and functional GI disorders", Hall A6/A7 3:45 – 5:15pm):

- 1. The Role of the Gut Microbiota in Functional GI Disorders: A Rome Working Team Report (Magnus Simrén, Sweden)
- 2. Pre-pro- and antibiotics in functional GI disorders: Evidence-based therapies? (Peter Whorwell, UK)

Objectives:

- To critically review the existing literature on the role of gut microbiota in functional GI disorders (FGIDs), with focus on clinical and translational aspects.
- Based on the literature search, provide recommendations how to implement the current knowledge into clinical practice, in order to improve the health of our patients.
- Give recommendations for future work in order to improve the current knowledge on the role of gut microbiota in functional GI disorders.
- Produce an extensive background document including all the relevant references and information of relevance, as well as a clinically useful, review, submitted to one of the major scientific journals in our field.

PLANNING FOR ROME IV

erhaps the most exciting initiative at this time is that of Rome IV. We have begun an innovative program to advance the field of Functional GI Disorders as never done before. Some of the important features of this program include: a) prospectively acquiring targeted data through support committees including evidence based assessment, primary care, multinational research, food and diet, Asian assessment of FGIDs, and severity, b) presentation of this new information at a full day symposium in 2013 when the Rome IV chapter committees begin, c) New book chapters covering expanded areas of interest (Women's health,

multinational aspects, intestinal microenvironment and biomarkers, pharmacogenomics, food and diet), d) online access for Rome IV with free text access and download of pdfs, and e) concurrent release of translations into several languages. We expect publication in a special issue of a reviewed journal and also publication of the Rome IV book with online accessibility by Spring, 2016. CHAPTER COMMITTEES

The committees will begin in 2013 and will produce the content for Rome IV which will be completed in early 2016. This will include diagnostic criteria and evidence based reviews and recommendations for their designated chapter. Currently the chairs and co-chairs have been selected and committee members will be identified in mid-2012.




